- Approved of the Minutes: Tabled to the next meeting.
- President's Report (RL):
- 1. **VTRID** There is no word about the BBQ event in Silver Lake. RL will reach out to them about it.
- VTDBHI+ At the VTDBHI event, the Brattleboro Deaf Club made a profit of \$98.00 and donated \$50.00 to VTAD. The club is interested in doing more fundraisers with the VTAD in the future.
- 3. **NAD -** RL inquired about the expenses (flight, hotel, and registration) that VTAD should cover for VH who will attend the NAD conference as a delegate. VH has agreed to seek a roommate.
- 4.
